# HOW TO REQUEST REPRINTS OF GARTNER PUBLISHED RESEARCH

### SELECT

desired research document  
and reprint format

- Determine your deliverable: HTML or paper
- HTML reprints are hosted on a Gartner server
- Paper reprints are printed in color on 100lb glossy paper
- E-mail your Gartner sales executive or submit your request to [reprints@gartner.com](mailto:reprints@gartner.com) Pricing information and the most current reprints agreement will be provided via e-mail

Please include the following information:

- Document title and code
- Deliverable format requested (HTML or paper)
- Accurate pricing
- Payment method (purchase order or credit card)

### CONFIRM

A Gartner reprints representative will confirm your request within 24 hours of receiving the signed agreement. If all information on the reprint agreement is correct and complete, your order will be confirmed for processing via e-mail or telephone.

---

### SUBMIT

Submit your intended promotional usage and language to [reprints@gartner.com](mailto:reprints@gartner.com) for review and approval. A Reprints representative will work with the Gartner Vendor Relations team to process approval. Vendor Relations' turnaround time is 24 to 48 hours. The Gartner Copyright and Quotation Policy provides further details on examples of acceptable language and uses of Gartner intellectual property, which you can view at [gartner.com/5\\_about/ombudsman/copyright\\_policy.html](http://gartner.com/5_about/ombudsman/copyright_policy.html).

- **Web (HTML) reprints:** Submit a mockup of how the reprint will appear on your Web site and/or will be used in your marketing campaign. This is required to process your approval request.
- **Paper reprints:** Submit explanation of how the reprints will be used.

### PROVIDE

A Reprints representative will provide the deliverable once the promotional language and usage have been approved. Promotion beyond the approved usage requires explicit written permission from Gartner.

---

### TURNAROUND TIMES

#### STANDARD

- **Paper:** 15 business days
- **HTML:** 5 business days

#### RUSH

(15% additional fee. Gartner must receive completed contract by 12:00 p.m. EST or by 12:00 noon in respective international Gartner office.)

- **Paper:** 5 business days (minimum). Please allow an additional 3 to 5 business days for international deliveries.
- **HTML:** 1 business day (minimum) via e-mail
